1. **Qualification:** MBBS degree from a recognized University. Valid registration with Delhi Medical Council. Must not have completed one year Junior Residency in any recognized institution including regular & adhoc period.
2. **Internship:** The candidate should have completed compulsory rotatory internship after 03.07.2021; this relaxation is in view of upcoming postponed post graduate NEET exam and acute shortage of JRs in current scenario.
3. **Pay scale:** Rs.56100 – 177500 of level 10 plus allowances as admissible under the rules.
4. **Age limit for Junior Residents:** 30 years for Gen, 35 years for SC/ST, and 33 years for OBC candidates on the closing date of submission of application.
5. **Other conditions/requirements:**
 1. OBC/EWS certificate issued by Govt. of NCT of Delhi shall only be accepted and the same must have issued before the date of interview. Further, the OBC certificate must possess Non Creamy Layer certificate for the current year along with his/her caste certificate.
 2. Candidates are required to bring all original certificates and testimonials along with two passport size photographs on the date of interview.
 3. No TA/DA will be paid for appearing in the interview.
 4. Hostel accommodation is mandatory for selected candidates subjected to availability.
 5. Number of the vacancies is provisional and subject to change without any notice.
 6. In case of non-availability of candidates under SC/ST/OBC/EWS category, vacancies may be filled up from the General category.
