#### Project Description: -

Saksham which means "Capable" or "Self- reliant" in Sanskrit is a TISS field project comprising of two projects: Saksham Pravaah & Saksham Pramaan.

Saksham Pravaah introduced counselling services for Drug Resistant (DR) TB patients in collaboration with the Central TB Division, Government of India. Given the demonstrated impact, Saksham Pravaah was entrusted to build capacities of TB Staff on counselling soft skills. In its fourth phase of intervention, Saksham Pravaah will expand the capacity building initiative to all cadres under the National Tuberculosis Elimination Programme and develop a state-of-the-art demonstration model for holistic Patient Care and Support.

**Saksham Pramaan-** Targeted intervention and programme evaluation is a three-year project as sub-recipient to NACO and is funded by the global Fund. The project has two components; first includes evaluation of Targeted Interventions (TI) and Link Worker Schemes (LWS), build capacities of the evaluators and to coordinate evaluations of all TI and LWS projects under NACP. Second component includes design and conduct concurrent and mid-term evaluation of select programmatic interventions under NACP.
