2. **Eligibility criteria:** The age, qualification and experience as on 01.01.2025 for the above posts are prescribed as under:

- a) In the case of candidates belonging to SC / ST /OBC / PH, minimum qualifying marks will be 45% in aggregate, other conditions remaining the same.
- b) The educational qualifications prescribed for all the above posts is the minimum. Candidates must possess the educational qualification as on 01.01.2025 (inclusive) and must attach proof of having acquired the qualifications on or before 01.01.2025.
- c) Applicants are required to have achieved the minimum pass marks in either Khasi or Garo during their Secondary School Leaving Certificate (or equivalent / higher) examination. Alternately, candidates may choose to undergo a proficiency examination to assess their proficiency in one of these languages if their academic records do not meet this criterion.
- d) Upper age limit is relaxable by five (5) years for SC/ST candidates, i.e., 35 years.

3. Important information regarding educational qualification:

In other words, the results of the qualifying examination, i.e., Graduation should have been declared on or before 01.01.2025. - 7. The Bank reserves the right to change any condition of recruitment mentioned here. Further the Bank reserves the right to cancel/amend the entire /part of the process of recruitment at any time without assigning any reason thereof. However, communication in this regard will be placed on the Bank's website.
- 8. Any other information, updates, etc., will be posted on the Bank's website and the Bank is not necessarily bound to communicate the same through any other means to the candidates. Hence, candidates are advised to visit the Bank's website, i.e., www.megcab.com, from time to time in connection with their application.

9. How to apply:

- a. Applications may be submitted only through ONLINE mode. Applications received through any other mode will not be accepted.
- b. Instructions for the online application are also provided on the application portal and in this advertisement. Candidates are advised to adhere to the instructions contained in this advertisement and on the portal while submitting their application.
- c. Candidates are required to upload scans of documents in support of their having passed the matriculation examination and other subsequent higher examinations as mentioned in the portal and as applicable to them, e.g., a candidate who has passed the Masters of Commerce examination will have to submit on the portal and also upload the necessary documents from matriculation onwards.
- d. Scans of the other documents as mentioned in the application portal and as applicable to the candidate are to also be uploaded.
- e. A colour photograph of full frontal (face) view with the head centred in the frame covering 70-80% of the photograph and taken within the last six months (only

- h. Scan of the ST / SC / OBC / PH Certificate issued by a competent authority (only in PDF formats with the extension .pdf will be accepted) should be duly uploaded.
- i. Valid age proof certificate (only in PDF format with the extension .pdf will be accepted) should be duly uploaded.
- j. Scan(s) of the certificate(s) of work experience in respective fields from employer, if any, should be duly uploaded. Only files in PDF format with file extension .pdf will be accepted for uploading.
- k. The originals of these documents may be verified at any appropriate time as decided by the Meghalaya Co-operative Apex Bank Ltd.
- l. An application will be rejected if it is found that the candidate does not meet the eligibility criteria.
- m. Candidates are advised to visit the Bank's website, i.e., <u>www.megcab.com</u>, from time to time to check the status of their application.
- n. An admit card will contain the following details of the candidate: Name, Roll Number for the written test, photograph, signature, examination schedule, examination centre details and instructions for the candidates besides any other information as deemed necessary by the Bank. - 10. **Selection process:** The selection of candidates will be made on the basis of performance in the written test followed by interview for shortlisted candidates. The written test will consist of objective / multiple choice type questions on General Awareness, Banking Awareness, Economic Awareness, Reasoning Ability, Computer

Aptitude, Quantitative Aptitude, Data Analysis, Data Interpretation and English Language. Final selection shall be made on the basis of ranking of the aggregate marks obtained in the Written Test and Personal Interview. Decision of the Bank in this regard shall be final.

The selected candidates will be on probation for a period which shall not be less than twelve (12) months (which may be extended at the discretion of the Bank). During the probation period, they will be entitled to Initial Basic Pay of Rs.45,114/- for the post plus admissible Dearness Allowance only. They will be required to undergo a course of training during the probationary period. Subject to satisfactory completion of the probationary period and on completion of the training course successfully, they will be absorbed in the Bank's services in the Bank's scale as applicable for Multi-Tasking Staff and thereafter they will be entitled to draw other allowances and facilities admissible to the post under the Staff Rules. Candidates should note that their services are transferable from one place to another within the State.

- 11. **Payment of TA/HA / DA:** Candidates will be required to appear at the written test /interview at their own expense and no allowances including TA/DA/HA will be paid for the purpose.
- 12. If, on verification at any stage of the recruitment process, it is found that applicants/candidates do not fulfill any of the eligibility conditions, their candidature for the post will automatically be cancelled by the Bank without notice.
